## NOTICE

Applications on the prescribed format are invited from desirous eligible students of **Batch 2023 (3<sup>rd</sup> Semester)** and **Batch 2022 (5<sup>th</sup> Semester)** of the College for the grant of Financial Assistance out of the Students Aid Fund. The students eligible to receive financial assistance from the Student Aid Fund shall be divided into three categories:

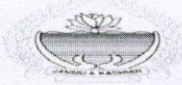
- A. **Orphan/broken family category:** The Students who shall benefit under this category must fulfill the following criterion:
- Having a monthly income of less than or equal to Rs 10000.
  - Certificate to this effect from the competent authority.
  - Applicants hailing from a broken family category have to produce a legal separation document to this effect and a cogent proof that the applicant resides with the non-earning parent.
- B. **Differently Abled/ students having Handicapped Parents:** The students who shall be benefited under this category must fulfill the following criterion:
- Applicants from this category shall furnish a certificate to this effect from a Competent Authority.
  - The percentage of disability should be above 40%
  - Income certificate from the competent authority.
- C. **EWS/AAY:** The students who shall be benefited under this category must fulfill the following criterion:
- EWS Certificate/AAY ration Cards
  - Income Certificate from the concerned Tehsildar with a monthly ceiling up to Rs 10,000/- is to be produced.

The eligible students shall submit their applications in the prescribed format duly complete in all respects with the Financial Aid Committee of the college **by or before 11<sup>th</sup> September, 2024.**

**Note:** Students who are in receipt of financial assistance from any other Government/Semi-Government agency shall not be eligible for the aforesaid assistance.
