

The candidates should possess the basic educational qualification as per Kerala Engineering Architecture Medical (KEAM) prospectus of relevant year of admission, for considering to the Supernumerary seats allotted for each course. The candidates should also have a valid ICAR score card of ICAR-AIEEEA-UG for the relevant year of admission.

The requisites as per KEAM -2024 are,

1 <u>For admission to B.Sc.(Hons.) Agriculture, B.Sc.(Hons) Forestry, B.Sc (Hons.) Cooperation & Banking, B.Tech Biotechnology (under (KAU)</u>

Candidates who have passed in the subjects Physics, Chemistry and Biology at the Higher Secondary Examination of the Board of Higher Secondary Education, Kerala or examinations recognised equivalent thereto, with 50% marks in Physics, Chemistry and Biology put together are eligible.

2 For admission to B.Sc.(Hons) Climate Change & Environmental Science:

Candidates who have passed in the subjects Physics, Chemistry and Biology at the Higher Secondary Examination of the Board of Higher Secondary Education, Kerala or examinations recognised equivalent thereto, with 50% marks in Physics, Chemistry and Biology put together are eligible. Candidates should have studied Mathematics as a subject in the Plus Two level.

3 B.Tech (Agri. Engg.) and B.Tech (Food Technology) courses

Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with Physics and Mathematics as compulsory subjects and Chemistry as one of the optional subjects with atleast 45% marks put together.

GENERAL ADMISSION PROCEDURES

- Candidates can submit applications in the application portal set up by KAU, during the application period which will be announced. All certificates/documents for proving the eligibility criteria for the course applied, as fixed by the University, should be uploaded in the portal.
- The collected applications/certificates/documents will be initially screened by the University to check if applications meet minimum basic academic requirements prescribed for each course, as stated above.
- KAU will review the applications and rank applicants. The scoring will be based on marks in the qualifying examination (Plus Two) as stated above. The index marks for courses listed against (1) & (2) above will be calculated as the sum of marks obtained in Physics, Chemistry and Biology and that for the courses noted against Sl.No.(3) will be the sum of Physics, Chemistry and Mathematics in the qualifying Ie, Plus

ORDER

The Government of India have introduced reservation policies to provide for an equal platform for everyone irrespective of their caste and economic status. Based on overall assessment of the requirements of residents of particular territories for whom it is essential to provide facilities for higher education and also to uplift such areas from their backwardness, reservation is being allowed on territorial, geographical or other reasonable basis, also.

The Ministry of Human Resource Development is having schemes of reservation of seats in Engineering, Technology, Architecture and Pharmacy courses conducted at Degree and Diploma level technical institutions approved by the All India Council for Technical Education (AICTE), for States and Union Territories (UTs) which do not have Engineering Colleges/Polytechnics or lack facilities for education in specific fields of Technical Education and for certain categories including foreign students. Kerala Agricultural University, being a public funded University is strictly following the reservation policies of the Government, during admissions.

As per the minutes read (1) & (2), it was proposed to create supernumerary seats to provide for an opportunity for higher education to the students from the UTs. It was recommended that two supernumerary seats each shall be created in each college under KAU to provide for reservation of seats in UG programmes for the residents of Union Territories with a fee of Rs. 1 lakh per semester.

The Special Academic Council as per paper read (3) has approved the proposal.

In the circumstances, the following orders are issued.

- Sanction is hereby accorded to create two supernumerary seats at each college under KAU to provide for reservation of seats in all Under Graduate programmes for residents of Union Territories from next Academic Year (2024-

- The candidates should possess the basic educational qualification as per Kerala Engineering Architecture Medical (KEAM) courses prospectus of relevant year of admission, for considering them to the Supernumerary seats allotted for each course.
- The candidates should have a valid ICAR score card of ICAR-AIEEEA-UG for the relevant year of admission.
- The above 20 supernumeraryseats will have a higher fee of Rs. 1 lakh per semester.
- The seat reservation will be applicable to all the 8 Union Territories of India, namely, Andaman & Nicobar Islands, Dadra and Nagar Haveli and Daman and Diu, Jammu and Kashmir, Lakshadweep, Chandigargh, National Capital Territory of Delhi, Ladak and Puducherry.
- The pre-requisite qualifications, detailed fees, availability of hostel accommodation, admission rules, regulations, procedures, last date etc will be communicated to the Officer concerned of the Union Territory every year.
- The General admission procedures are ordered as below.
 - Candidates can submit applications in the application portal set up by KAU, during the application period which will be notified/announced in the KAU website. All certificates/documents for proving the eligibility criteria for the course applied, as fixed by the University, should be uploaded therein.
 - The collected applications/certificates/documents will be initially screened by the University to check if applications meet minimum basic academic requirements prescribed for each course.
 - KAU will provisionally rank the applicants. The scoring will be based on marks in the qualifying examination (Plus Two) as stated above. The index marks for courses listed against (1) & (2) above will be calculated as the sum of marks obtained in Physics, Chemistry and Biology and that for the courses noted against Sl.No.(3) will be the sum of Physics, Chemistry and Mathematics in the qualifying ie, Plus Two examination. If there is tie in Science/Mathematics marks, then the marks of English and then the marks of Additional language/second language will be considered.
 - KAU will send notification to the Union Territory concerned for furnishing the selected candidates with the nomination letter from the authorities. The selected applicants will also be notified of their acceptance through e mail.
 - The candidates will confirm their acceptance of allotted seat by a specific deadline fixed by the University and also physically report for submission of

original certificates, payment of fee and enrollment in the University.

The above reservation scheme will be applicable from the Academic Year 2024-25 onwards.
