ANTI- RAGGING POLICY DOCUMENT

#### Introduction

The Ragging is defined as any disorderly conduct, whether by words spoken or written or by an act, has the acc. act, has the effect of teasing, treating, or handling with rudeness a fresher or a junior student. Indulging in a rowdy or undisciplined activity that causes or is likely to cause annoyance, hardship or part is hardship, or psychological harm or to raise fear or apprehension thereof in a fresher or junior student. A claim of the student of the students will not do in student. Ragging is a criminal offense and UGC has framed regulations on curbing the menace of ragging in higher educational institutions in order to prohibit, prevent and eliminate the scourge of ragging. In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, in exercise of the powers conferred by clause (g) of sub-section (1) of section 26 of the University Grants Commission Act, 1956, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009". These regulations have been adopted by the Govt. Degree college Sopore. Our college is fully committed to complying with the UGC regulations. This regulation shall apply to all students, employees (irrespective of their tenure, Position, Designation, or Gender),

# OBJECTIVES OF THE ANTI-RAGGING COMMITTEE:

- Formulation of Anti-Ragging Policy and constitution of Anti-Ragging Committee are important in order to root out ragging in all its forms from the college through prohibiting it by law, preventing it's occurrence by following the provisions of the (i) UGC regulations and punishing those who indulge in ragging as provided for in these Regulations and the appropriate law in force.
- Ragging in any form is a reprehensible act and is of no good to anyone.
- The Anti- Ragging Committee of Sopore degree College is dedicated to create and (ii) maintain ragging-free environment with a zero-tolerance policy towards any such (iii) behavior.
- Every act of ragging, major or minor, is beyond the limits of decency, morality and humanity and no such act will go unnoticed in compliance with Zero Tolerance (iv) Policy and nobody, male or female, student or non-student shall be exempted from punishment, if found guilty.

## REDRESSAL OF RAGGING CASES:

- The Anti-Ragging Committee (ARC) members shall note down the complaints In instances of any reported case of ragging and arrange for security of the victim or the complainant (i)
- The complaint shall be documented in an official file of the committee.
- A meeting shall be held in consultation with the members of Anti Ragging (ii) committee to resolve the issue and to decide upon the course of action. (iii)
- The actions against the alleged if found guilty shall be recommended by the Anti Ragging Committee (ARC) to the Head of the institution. (iv)
